**PRIORITY OF ACCESS EXPLAINED**

The Australian Government has 'Priority of Access Guidelines' to ensure a fair system for allocating places when there is a waiting list for a child care service or when a number of parents are applying for a limited number of vacant places.

Every Child Care Benefit approved child care service has to abide by the guidelines and tell you about them when you enrol your child into care.

Priority of Access is determined by the following circumstances. Please tick the circumstances relevant to your family noting that you may be required to provide proof under Section 14 of the Family Assistance Act.
